**PLEASE TAKE NOTICE**, that in accordance with the Open Public Meetings Act, N.J.S.A. 10:4-6 et seq., and in consideration of Executive Order No. 103, and other Executive Orders issued by Governor Murphy, declaring a State of Emergency and a Public Health Emergency in the State of New Jersey, the New Jersey Firemen's Home does hereby notify the public that the regularly scheduled Meeting of the Executive Board of Managers of the New Jersey Firemen's Home scheduled for May 8, 2021 **commencing at 9:00 a.m.** will be held online through ZOOM. The meeting shall be attended solely by members of the Executive Board and the Superintendent. No other person(s) shall be admitted.
